OHA Innovator Agent Update

Awab Al-Rawe provided the CAC with an update and overview focusing on:

- Public Health Emergency and Benefits
 - o Because of the extension:
 - Emergency SNAP benefits continue in August
 - Redeterminations for OHP will NOT begin until the PHE ends
- System and Process Changes to Support People
 - Self-service option through the ONE Portal
 - OHA is Partnering with CCOs to gather contact information updates directly
 - During the PHE Unwinding members will have 90 days to provide any information required to complete their renewals

- Nationwide 988 Suicide and Crisis Lifeline
 - The 988 Suicide and Crisis Lifeline is available 24/7 for people experiencing a behavioral health crisis to call, text or chat online at 988lifeline.org.
 - o Calls may be responded to in English or Spanish.
 - Text and online chat are currently only available in English.

Board Report

Sharif Maddox provided the CAC with an update on what took place during the July 21st Trillium Board of directors Meeting.

 - Suellen Narducci presented the Operations dashboard with information as of the end of May 2022 with a focus on metrics from the following areas:
 - Diversified Growth
 - Compliance

 - Appeals and Grievances
 - Quality
 - Membership Trends
- Medicaid Update
 - Courtney Johnston provided the Board with a Medicaid Update with a focus on:
 - The Status of the Corrective Action Plan
 - Trillium's Corrective Action Plan is officially closed. We have met all of the OHA's expectations. They may follow up on items after 6-12 months.
- Eligibility Changes
 - When the federal government closes the Public Health Emergency, everyone who receives Medicaid will be required to confirm their income to show if they are eligible to continue to receive the Oregon Health Plan. This will be a big undertaking and is expected to start sometime in 2023 and will take 14 months.
 - In July, the state began covering undocumented citizens between the ages of 19-25 and above the age of 55

- TQS Update
 - The Transformation and Quality Strategy Plan is submitted by each CCO on an annual basis and outlines projects the CCO is working on to improve quality for their members. Trillium is very proud of their score, which was better than Health Share's.
- BH Update
 - It is difficult for members to access behavioral health services due to workforce shortages. Trillium is working closely with the OHA which received legislative funds to increase reimbursement for Behavioral Health services. Trillium is doing all they can to support that work.
