Sheri presented the slides that were sent ahead of the meeting for CAC members to review, per CAC request.

Reminded CAC voting members their role is to review funding proposals for SHARE and make a motion to approve or not approve. The projects should align with our Community Health Improvement Plan, Trillium & OHA priorities and the priorities the CAC approved in March.

Comments and questions:

1. Is the training only for Spanish speaking PSS training? **Yes**
2. If someone is Latino but does not speak Spanish, can they participate? **The training is specific to Spanish speaking Peers.**
3. Is the training only for PSS THW type? **Yes.**
4. Does Juntos provide help finding jobs? **No. But they have relationships with other organizations they can direct individuals who have completed the training.**
5. Will they support Spanish speakers that speak other dialects? **The training is focused on Spanish speaking only.**
6. Is the training virtual? **Yes.** Attendees statewide? **Yes**

1. Ages served 12 – 18 and [ASAM 3.5](#) Clinically managed high-intensity residential
2. Education – in residential facilities for youth, have been difficult for those outside the county to enroll. Does their school allow all the residents to be served? Yes.
 - 4 D – only enrolls Multnomah County residents with school. Appreciate the call out for the variation with 4 D
