- Emergency Department Information Exchange (EDIE) is a new integrated software that is in real time that sends out information to providers about their patients; for example, if a provider's patient is checked into the E.R. Every patient will have a care plan entered into EDIE. Other agencies, such as Pacific Source, etc., will also be using it. The highest use in the E.R. is Monday mornings 9 am 2 pm.

 - Oral Health Workgroup collaborative for varnish and dental sealants.

- Same day transportation to medical appointments.
- More urgent care access.
- Better pain management outside of emergency room.
- Series of lectures on pain management and opiate addiction.

- Still working on integration of care.
