### About the CCO Community Advisory Council

ORS 414.625, Coordinated Care Organizations (CCO) says we must have a Community Advisory Council (CAC). The CAC makes suggestions to the CCO Governing Board in order to make sure that health care needs of members and the community are being met.

#### The CAC must:

- Include people in the community
- Have OHP members make up the majority of membership
- Meet at least once every 3 months
- Have its membership chosen by a committee made up of equal numbers of county representatives and members of the CCO Governing Board

#### CAC Member Roles and Responsibilities

The duties of the CCO Community Advisory Council include:

- Identify and support preventive care practices to be used by the CCO
- Develop a community wellness program
- Publish a yearly report that includes a review of the work of the CCO and suggestions made to the Trillium Governing Board for change improvements.

#### Other requirements:

- Members should be willing to serve a 2-year term limit.
- Members of the Trillium CAC can serve more terms if approved by the Trillium CCO Governance Board.
- Members should plan to attend CAC meetings at least quarterly, but no more than monthly. Frequency, day, and time to be determined at orientation in March, 2021.

### Rural Advisory Council

The Rural Advisory Council works with the Community Advisory Council and the Governing Board to make sure the health care needs of rural members and communities are being met. The RAC also make sure that the care provided in urban areas are aware of the needs of rural members.
