# Trillium Medicaid ADVANCE DIRECTIVE



If you are an adult, you have the right to know about all your health care choices. You can say no if you do not want what your doctor says is best. But if you have a serious sickness or are suddenly hurt, you may not be able to say what you want. Then your relatives would have to speak for you.

Oregon has a law that lets you say what you would want the doctor to do before you get very sick or hurt. The papers that tell your choices are called an Advance Directive. The Advance Directive lets you name a person who will tell the doctor what you want if you cannot talk. This person is called your health care representative. Your health care representative does not have to be a lawyer or know all about health care. It should be someone you trust and have talked to about what you want. Your health care representative must agree in writing to make the same decisions that you would.

The Advance Directive lets you tell health care workers what they should do if you cannot speak to them. The Advance Directive lets you tell your doctor to stop life-saving help if you are near death. This tells your doctor that you do not want your life to continue if two doctors say you will not get better from an injury or sickness or disease. You will get help for pain and to make you comfortable no matter what choices you make.

The Advance Directive is only good if you sign it when you can understand it. The Advance Directive will not end unless you decide to make it for a shorter time. You also may stop your Advance Directive at any time. You have the right to decide your own health care as long as you are able to, even if you have an Advance Directive. Filling out the Advance Directive is your choice. If you do not fill out and sign the Advance Directive form, it will not change your health plan coverage and you can still see a doctor.

You may have a wish that a certain doctor or hospital cannot follow because of a moral or religious belief. You should discuss your Advance Directive with them. (42 CFR 422.128, ORS 127.505 and 127.625)

#### **ADVANCE DIRECTIVE**

#### YOU DO NOT HAVE TO FILL OUT AND SIGN THIS FORM

#### PART A: IMPORTANT INFORMATION ABOUT THIS ADVANCE DIRECTIVE

This is an important legal document. It can control critical decisions about your health care. Before signing, consider these important facts:

#### Facts About PART B (Appointing a Health Care Representative)

You have the right to name a person to direct your health care when you cannot do so. This person is called your "health care representative." You can do this by using PART B of this form. Your representative must accept on PART E of this form.

You can write in this document any restrictions you want on how your representative will make decisions for you. Your representative must follow your desires as stated in this document or otherwise made known. If your desires are unknown, your representative must try to act in your best interest. Your representative can resign at any time.

### Facts About PART C (Giving Health Care Instruction)

You also have the right to give instructions for health care providers to follow if you become unable to direct your care. You can do this by using PART C of this form.

#### Facts About Completing This Form

This form is valid only if you sign it voluntarily and when you are of sound mind. If you do not want an advance directive, you do not have to sign this form.

Unless you have limited the duration of this directive, it will not expire. If you have set an expiration date, and you become unable to direct your health care before that date, this advance directive will not expire until you are able to make those decisions again.

You may revoke this document at any time. To do so, notify your representative and your health care provider of the revocation.

Despite this document, you have the right to decide your own health care as long as you are able to do so.

If there is anything in this document that you do not understand, ask a lawyer to explain it to you.

You may sign PART B, PART C, or both parts. You may cross out words that don't express your wishes or add words that better express your wishes. Witnesses must sign PART D.

NOTE: You may not appoint your doctor, an employee of your doctor, or an owner, operator or employee of your health care facility, unless that person is related to you by blood, marriage or adoption, or that person was appointed before your admission into the health care facility.

# PART B: APPOINTMENT OF HEALH CARE REPRESENTATIVE (CONTINUED)

1. <u>Limits.</u>
Special Conditions or Instructions:

2. <u>Life Support.</u>
"Life support" refers to any medical means for maintaining life, including procedures, devices and medications. If you refuse life support, you will still get routine measures to keep you clean and comfortable.
INITIAL IF THIS APPLIES:
My representative MAY decide about life support for me. (If you don't initial this space, then your representative MAY NOT decide about life support.)
3. <u>Tube Feeding.</u>
One sort of life support is food and water supplied artificially by medical device, known as tube feeding.

My representative MAY decide about tube feeding for me. (If you don't initial this space, then your representative MAY NOT decide about tube feeding.)

#### PART C: HEALTH CARE INSTRUCTIONS

NOTE: In filling out these instructions, keep the following in mind:

- The term "as my physician recommends" means that you want your physician to try life support if your physician believes it could be helpful and then discontinue it if it is not helping your health condition or symptoms.
- "Life support" and "tube feeding" are defined in PART B above.
- If you refuse tube feeding, you should understand that malnutrition, dehydration and death will probably result.
- You will get care for your comfort and cleanliness, no matter what choices you make.
- You may either give specific instructions by filling out Items 1 to 4 below, or you may use the general instruction provided by Item 5.

Here are my desires about my health care if my doctor and another knowledgeable doctor confirm that I am in a medical condition described below:

1. <u>Close to Death.</u> If I am close to death and life support would only postpone the moment of my death:

3. Advanced Progressive Illness. If I have a progressive illness that will be fatal and is in an advanced stage,

and I am consistently and permanently unable to communicate by any means, swallow food and water safely, care for myself and recognize my family and other people, and it is very unlikely that my condition will substantially improve:
A. INITIAL ONE: I want to receive tube feeding. I want tube feeding only as my physician recommends. I DO NOT WANT tube feeding.
B. INITIAL ONE: I want any other life support that may apply. I want life support only as my physician recommends. I want NO life support.
4. <u>Extraordinary Suffering.</u> If life support would not help my medical condition and would make me suffer permanent and severe pain:
A. INITIAL ONE: I want to receive tube feeding. I want tube feeding only as my physician recommends. I DO NOT WANT tube feeding.
B. INITIAL ONE: I want any other life support that may apply. I want life support only as my physician recommends. I want NO life support.
5. <u>General Instruction.</u>
INITIAL IF THIS APPLIES: I do not want my life to be prolonged by life support. I also do not want tube feeding as life support. I want my doctors to allow me to die naturally if my doctor and another knowledgeable doctor confirm I am in any of the medical conditions listed in Items 1 to 4 above.

NOTE: One witness must not be a relative (by blood, marriage or adoption) of the person signing this advance directive. That witness must also not be entitled to any portion of the person's estate upon death. That witness must also not own, operate or be employed at a health care facility where the person is a patient or resident.

## PART E: ACCEPTANCE BY HEALTH CARE REPRESENTATIVE

I accept this appointment and agree to serve as health care representative. I understand I must act consistently with the desires of the person I represent, as expressed in this advance directive or otherwise made known to me. If I do not know the desires of the person I represent, I have a duty to act in what I believe in good faith to be that person's best interest. I understand that this document allows me to decide about that person's health care only while that person cannot do so. I understand that the person who appointed me may revoke this appointment. If I learn that this document has been suspended or revoked, I will inform the person's current health care provider if known to me.
